# Letter From the President

In 2024, Them Before Us grew.

A lot of organizations say that, but our plucky nonprofit expanded in every way an organization must if they are serious about protecting children across the globe.

We grew our reach. With our publishing, speaking, and presenting on over 100 platforms, the message of putting children before adults resonated on six continents. We fortified those who already agreed

with us but struggled to speak effectively about our issues. We changed minds, receiving countless messages of marriages mended, child-victimizing technologies rejected, and child-protective positions embraced.

We grew our staff. In 2023, we had two full-time staff. We wrapped up 2024 with five. As I often say, those five do the work of ten. Despite living in three different time zones and rarely seeing one another in person, our cohesion and camaraderie makes for effective and joyous work.

We grew our programs. We crafted guidance for corporations, published a book that applied our child-first message to all national, economic, and cultural issues, launched a small group curriculum pairing scripture and natural law, and produced a weekly radio program on the second largest Christian broadcaster in the nation.

We grew our support. For the first time since I founded Them Before Us in 2018, we systematically invited fans and followers to financially partner with us. We held events in Seattle, Charlotte, and Austin, and met with hundreds of supporters at coffee shops or on Zoom throughout the year. The result was amazing and humbling, as we surpassed our revenue targets.

And that, my friends, makes for a very exciting 2025.

After a year of explosive growth, some non-profits might play it safe. We are not that non-profit. You are not giving sacrificially so we can coast. You're partnering with us so we can wage war on behalf of children. And that's exactly what we intend to do.

## Year In Review

This year, Them Before Us continued to make significant strides in defending children's rights and ensuring their needs remain the focus of every conversation about marriage and family. The team delivered keynote addresses at events across the country, published articles in major outlets, and provided critical insights that influenced policymakers and cultural leaders. Engagement with media platforms and podcasts expanded the reach of the pro-child message, highlighting the harms of surrogacy, family breakdown, and the intentional severing of a child's connection to their biological parents. Thanks to the unwavering support of donors and advocates, Them Before Us remains committed to putting the needs of children first and advancing this movement into 2025 and beyond.

# **Programs**

At Them Before Us, our mission is to prioritize children over adults through two key efforts: **changing hearts** and **changing laws**.

We change hearts by reshaping cultural attitudes: providing interviews, media content, and a church curriculum that highlight a child-centric perspective on marriage, family, and reproductive technologies.

To change laws, we educate about policies that protect children from exploitation and loss. Our book *Pro-Child Politics* and our Child-First HR Benefit program help equip policymakers and business owners with ethical frameworks and policy recommendations, ensuring children's needs are prioritized over adult desires.



## **Changing Hearts**

### **Church Engagement**

We have a 7-session video series and accompanying workbook for church small groups. This curriculum will educate Christians on why God's design for sex and marriage is critical to child protection.

# **Changing Laws**



#### **Pro-Child Politics**

From porn to debt, energy to the environment, 19 experts detail a child-centric approach to policy. *Pro-Child Politics* tutors the electorate on a Them Before Us perspective to ensure the next generation will not only survive, but thrive.

#### **Child-First HR Benefits**

Them Before Us has developed a Children-First Human Resources Package to guide companies in using their corporate influence to support, rather than violate, children's rights and wellbeing. Many corporate health plans harm children through policies that include abortion and unethical "family building" options. This initiative provides companies with actionable guidance to prioritize children's best interests in their benefits programs. Alongside the package, TBU has produced a high-quality short video exposing how corporate benefits often

undermine children's rights.

## Children's Rights Database

Our Children's rights database will be an interactive platform enabling users to survey relevant laws, policies, and court rulings pertaining to marriage, IVF, parentage, surrogacy and donor conception, and divorce state-by-state. Each state will be scored in multiple categories, and users will be able to see how their state could improve through Them Before Us' proposed reforms.






# **Exposing "Corporate Equality"**
